Protection of high value cold water lake habitats. Reduction of sediment from actively eroding shorelines and disturbed banks throughout the project area.

Dear Mr. Burgan,

Attached you will find a planning document detailing the proposed lake shoreline stabilization work, inlet and outlet improvements, and dredging plans for the seven fishing lakes on the Elk Mountain Ranch in Carbon County, Wyoming. As per our discussions during the site visit in April 2007, you will also find two permit applications (ENG Form 4345); one for the lake shoreline stabilization project, and one for the new "E" Channel connecting Arapaho Lake and the "Swim" Pond.

We are requesting that the shoreline stabilization portion of the project be authorized under Nationwide Permit #13 - Bank Stabilization. Projected outcomes for this portion of the project will be stabilizing and re-vegetating 7,140 linear feet of actively eroding shorelines on five large lakes on the Ranch. The treatments areas represent approximately 30% of the total shoreline perimeter of the lakes.

During our discussions in April, there was some question whether the Arapaho Lake/Swim Pond Outlet and Channel Improvements portion of the project was a connected water, and therefore jurisdictional under Section 404 of the Clean Water Act of 1972, as amended. I have prepared an application for this work anyway, and request that it be considered under the regional 80-202 authorization for smaller habitat enhancement projects. The projected outcome of this project will be improved capability to regulate flows throughout the year out of Arapaho Lake and into the Swim Pond, resulting in improved water quality for trout in the Swim Pond, particularly in the late summer and fall. If you determine that aNWP #27 is the most appropriate authorization for this work, please contact me at the e-mail address above so that I may prepare an application for a State of Wyoming Section 401 Certification.

As discussed in April, we will conduct the lake excavation work in a manner that will be non-jurisdictional under Sec. 404. I have included the dredging plans for your review to ensure that they meet the Corps expectations for non-jurisdictional dredging. Also, I assume that the Trophy Lake diversion structure maintenance described in the project documents will fall under the irrigation/water rights exclusion. If this is not the case, I can prepare a separate application for this work.

We hope to start this project in October 2007, but recognize that this schedule is dependant on the disposition of the permit applications. Please let me know if you feel this timeline is not realistic. You may call me at any time if you wish to further discuss the details of this project. If you like, I can also arrange a site visit if necessary. I am scheduled to conduct assessments on the Elk Mountain Ranch during the weeks of July 9 and July 16. I look forward to working with you on this effort.
